Firms that participated were required to complete a two-step survey conducted by Best Places to Work Group. First, an employee questionnaire was completed by the firm's HR department that captured information around benefits, retirement, training and development and incentive structure, among other topics. Second, employees completed a 78-question survey which looked at several elements of being an employee at Voya—including engagement and satisfaction, work environment, career development and remuneration in addition to two open-ended questions about working at Voya.

"We believe our culture is unique, special and above all else, our competitive advantage," said Michael Pratt, managing director and head of Human Resources for Voya Investment Management. "Employees describe our culture as having a family-like feel where they are empowered to balance work/life commitments and cited how we support one another in challenging times. We also hear from new hires about how appreciative they are for being in an entrepreneurial environment, where they have the opportunity to make changes and positive impacts to our clients."

In addition to this accolade, earlier this year Voya Financial received a perfect score of 100 percent on the 2017 Corporate Equality Index (CEI) — a national benchmarking survey and report on corporate policies and practices related to lesbian, gay, bisexual, transgender and queer (LGBTQ) workplace equality — administered by the Human Rights Campaign (HRC) Foundation. The 2017 Index marked the 12th consecutive year that Voya has received a perfect CEI score.
